## **PARKING POLICY RULES AND REGULATIONS**

- ☐ The student must maintain good school attendance, punctuality and demonstrate the Spartan Way at all times. Students who are chronically tardy will have their driving privileges suspended or revoked.
- ☐ Parking permits must be properly displayed and visible on the rear-view mirror at all times while on school property. Permits lost, damaged or stolen must be reported to the Security office.
- ☐ All provisions of the New York State Motor Vehicle and Traffic Laws must be obeyed.
- ☐ Drivers of a motor vehicle on school property must obey all posted signs and security directives while driving in a safe, lawful manner.
- ☐ The student must park in the West Lot, west of the yellow line. (In front of the Field House)
- ☐ Student will be assigned a parking spot. This spot will be numbered. Student must park in this assigned n numbered spot only.
- ☐ No student is to be in the parking lot or in any car during school hours unless written permission has first been obtained from the Grade Level Administrator or Security Office.
- ☐ **All vehicles are subject to search at any time.**
- ☐ Gates Chili does not have an open campus. Students may not leave campus without parental permission during the school day and must follow all sign out procedures.
- ☐ **We have read all the rules outlined above and understand that failure to comply with these rules and regulations may result in the following: disciplinary action from the Grade Level Administrator and/or Security, cancellation of the student parking permit.**
- ☐ **Failure to conform to our regulations may result in the vehicle being towed at driver's expense and revocation of parking privileges.**
